Web Based Distributor Sales Policy

This Agreement is entered into by and between the undersigned Web Based Distributor (hereafter Web Distributor) and Armament Systems and Procedures, INC (hereafter ASP). Web Distributor clearly understands and agrees to be bound by the terms herein, including the ASP sales, delivery, service and warranty policies.

GENERAL SALES POLICY

An opening order for at least one of each Core Collection product is required for a Web Distributor account. Annual sales volume of at least \$5,000.00 in ASP merchandise at Web Distributor price (35%) is a requirement for annual Web Distributorship renewal. Products are shipped in accordance with published prices in effect at the time of shipment. The terms and conditions of the ASP Sales Policy are in effect through December 31 of the year of this contract. ASP reserves the right to change this Sales Policy without notice.

WEB DISTRIBUTOR QUALIFICATION

All new ASP Web Distributor accounts must be personally interviewed and set up by an ASP Technical Support Manager. Establishment of an ASP account is at the sole discretion of ASP. Web Distributors are selected according to their standing in the community and ability to meet ASP Web Distributor qualifications. ASP appoints only a limited number of Web Distributors worldwide. All ASP Web Distributors must maintain a full time order taking Web site business and hold a current state sales tax license. Web Distributors must stock and display on their Web site all Core Collection products. Part time or special order Web Distributors cannot be accepted. To maintain an ASP account, Web Distributors must:

- a. Instruct sales personnel in the technical knowledge necessary to adequately demonstrate and sell ASP products.
- b. Prominently display ASP Logos on their Web site.
- c. Order at least \$5,000.00 of ASP merchandise each year at Web Distributor price.

WEB DISTRIBUTOR DISCOUNT

Web Distributor pricing is 35% off the retail price. A \$25.00 surcharge will be added to orders of less than \$250.00 at Web Distributor cost.

MAP PRICING

The ASP Unilateral Minimum Advertised Pricing Policy is in effect for all products listed on the ASP price schedule. MAP pricing for all ASP products is 15% below suggested retail price.

WEB SITE SALES

Only registered ASP Distributors are authorized to use ASP trademarks and copyrighted images on the World Wide Web (www). It is the policy of ASP to vigorously enforce the authorized use of its protected trademarks and images. Web sites violating terms of the ASP Sales Agreement should be reported to ASP.

TERRITORY

Web Distributors may sell ASP products only in the country they are based. Determination of the acceptability of sales for a specific area is at the sole discretion of ASP. Unless otherwise agreed in writing, Web Distributors shall not quote or sell ASP products in foreign countries. Quoting, selling or shipping ASP products outside of the designated sales territory will result in termination of the Web Distributorship, void product warranties and preclude factory repair service.

WEB DISTRIBUTOR SALES

The sale of ASP products to other Web Distributors is prohibited. Selling or shipping ASP products to other Web Distributors will result in termination of the Web Distributorship.

CORE COLLECTION

Web Distributors must display all ASP Core Collection products on their Web site.

LABELING

All ASP products display Uniform Product Council (UPC) machine readable bar code labels. There is a charge of \$.25 per application of additional product labels.

ORDER CHANGE

Once an order has been entered into the automated shipping system, any changes will require a \$25.00 processing fee which will be added to the invoice.

DROP SHIPMENT

Drop shipping is not available for Web Distributors.

FREIGHT AND HANDLING

All products are FOB Appleton. Shipment is made via UPS wherever possible. A street address (not Post Office Box) is required for all orders. Each ASP order is subject to a \$5.00 handling charge for the first box and \$1.00 for each additional box or a \$25.00 domestic and \$50.00 international per pallet charge. Full freight and handling, excluding UPS Next Day, 2nd Day, 3rd Day and Federal Express charges, is allowed on all US orders totaling \$2,000.00 or more at Web Distributor cost when paid in full within 10 days from invoice date. Application for freight and handling allowance must be submitted within 90 days of the invoice date.

TERMS

All invoices are Net 30. A 3% discount (less freight) is allowed on orders paid within 10 days of invoice date. Web Distributors who do not have an established credit history with ASP must provide, a credit card number (Visa, MasterCard, American Express, Discover) or arrange a wire transfer to assure payment of their account. This 3% discount is allowed on wire transfer payments. A 3% discount is not allowed on credit card payments. The wire transfer fee must be paid by the Web Distributor at both the point of origination (Web Distributor's bank) and the point of receipt (ASP's bank). The ASP bank wire transfer fee will be waived for a payment totaling \$10,000.00 or more that is paid within discount terms.

COOPERATIVE ADVERTISING

Cooperative Advertising is not available for Web Distributors.

MASTER WEB DISTRIBUTOR REBATE QUALIFICATION

To qualify for a rebate under the Master Web Distributor Program, the Web Distributor must carry and promote the full line of ASP products.

BACK ORDERS

Due to the unprecedented demand for ASP products, occasionally ASP may be unable to fill an order completely. Back ordered items will be noted on the invoice and shipped as promptly as possible.

PAST DUE ACCOUNTS

ASP reserves the right to refuse shipment and cancel Web Distributor discounts on past due accounts. A finance charge of 1.5% per month (18% per year) is added to all past due balances. This interest rate is modified consistent with prevailing state laws and exchange rates. Accounts past 60 days will be placed on COD status. Accounts past 90 days will be closed.

RETURNED CHECKS

Checks returned by the bank for any reason will be subject to a \$50.00 service charge and is cause to terminate this Agreement.

COLLECTION

In the event that collection is required, the Web Distributor agrees to pay all ASP's costs and expenses in securing the unpaid indebtedness including actual attorney fees.

ORDERING

Include your Web Distributor number on all orders to insure proper discount. Use product code numbers on all orders. Any order received with incomplete information will be shipped in the most popular configuration.

PRICING

All prices are subject to change without notice.

RETURNS

- Authorization from the factory or a Return Authorization (RA) Number are not required for return shipments.
- Only Items currently on the ASP price list can be returned.
- Products with expiration dates can only be returned within 90 days of their purchase.
- Stock balancing is allowed at the time of return.
- Non-balanced merchandise returned through no fault of ASP is subject to a 20% restocking charge.
- Refurbishing or repair costs required to put returned merchandise in new condition will be assessed in addition to the 20% restocking charge.
- Returns must be shipped prepaid to ASP.
- Invoice numbers on which return items were originally received are required for credit.

SHORTAGE CLAIM

ASP is not responsible for shortage or damage incurred during shipment. Contact the carrier to report opened or damaged parcels. Shortage or incorrect order claims against ASP must be made within ten (10) days of delivery after which no claims will be accepted.

TERMINATION

This Agreement terminates December 31 of the year of this contract. In addition, ASP retains the right to terminate a Web Distributor for cause due to violation of any condition set forth herein. ASP retains the option to terminate a Web Distributor upon transfer of ownership, failure to meet credit requirements or delinquency of the account. Purchase of less than \$5,000.00 of ASP merchandise at Web Distributor cost during any calendar year or the sale, bidding or shipment of ASP products into foreign countries in violation of this Agreement constitute cause for termination.

WARRANTY

All products are warranted to be free from defects in material or workmanship. Specific product warranties are packaged with each item. No warranties will be honored on products sold into foreign countries in violation of the terms and conditions of this Agreement. In such cases, warranty service or replacement becomes the sole responsibility of the selling Web Distributor.

SERVICE

ASP maintains a service repair department in Appleton, Wisconsin. Prices for such repairs shall be fair and reasonable. Products returned for warranty repair will be processed on a no charge basis. Repair due to damage or misuse will be billed at a fair and reasonable service rate. Merchandise returned to the factory for service will be processed as promptly as workloads permit. A repair estimate will be provided prior to any non-warranty work. No factory repair service will be provided on products sold into foreign countries in violation of the terms and conditions of this Agreement. In such cases, service or repair becomes the sole responsibility of the selling Web Distributor.

DIRECT SALES

ASP reserves the exclusive right to sell and deliver ASP products directly to agencies of the United States Government, foreign governments, its own employees and OEM accounts.

PRODUCT AWARENESS

ASP will provide national training and advertising. Sales aids will be provided to Web Distributors on a no charge basis at the option of ASP.

TRADE SECRETS

This Agreement, all technical information about ASP products, information about the pricing and distribution of ASP products and the identities of customers of ASP are confidential trade secret information entrusted to Web Distributor solely for use in its capacity as a Web Distributor of ASP products and shall not be divulged to any person outside of Web Distributor's employ except with the written consent, or at the written direction of ASP. The terms of this paragraph survive termination of this Agreement.

TRADEMARKS AND TRADE NAMES

Web Distributor shall not use, except with regard to the resale of ASP products, the trademarks and trade names used by ASP for the sale of ASP products, including, but not limited to, the trademarks ASP, Tactical Baton, the ASP Eagle logo, the Strike Force logo or any similar marks or trade names that may confuse or tend to confuse customers with regard to product origin or endorsement. ASP is the sole and exclusive owner of and has all right, title and interest to its trademarks and trade names and reserves all rights and remedies for infringement thereof. The terms of this paragraph survive termination of this Agreement.

INSTRUCTIONS

All ASP products are packaged with complete instructions. These instructions must be read in order to ensure that ASP products are handled and used in a safe manner. It is the Web Distributor's responsibility to ensure that this material is provided to the customer. Web Distributors must include this material with each ASP product sold.

WEB DISTRIBUTOR INPUT

ASP has been built on the input received from Distributors and their customers. Suggestions concerning new products, modifications to existing products or changes in sales procedures, pricing and distribution are encouraged. ASP will periodically survey all Distributors to obtain input regarding products being considered for introduction. In addition, preproduction samples of new products may be sent to Web Distributors who serve on the ASP Test Panel. Web Distributors interested in obtaining information concerning a position on the panel should contact the factory.

SALES REPRESENTATIVES

For prompt personal attention and professional assistance, contact the factory for the name of the ASP Technical Support Manager for your area.

APPLICABLE LAW

This Agreement shall be construed and governed by the laws of the State of Wisconsin, USA, and all actions based on this Agreement or for breach thereof shall be venued in the Circuit Court for the State of Wisconsin, Milwaukee County, or the United States District Court for the Eastern District of Wisconsin.
